Know Your Rights from the ACLU: Regardless of your immigration status, you have guaranteed rights under the U.S. Constitution. Learn more about your rights as an immigrant, and how to express them.

Immigrant Defense Project: Find comprehensive guides, posters, and graphics in 10 different languages, including Arabic, Spanish, and Urdu. This is also a resource to know your rights once you are detained. For more information, call the Criminal Immigration Helpline at (212) 725-6422.

National Immigrant Justice Center: Find helpful samples of ICE arrest warrants and judicial warrants. Note: judicial warrants are still required to enter someone's home.

Rochester Rapid Response Network (RRRN): An emergency response hotline available for anyone to access if they feel they are in danger of arrest and/or detention.

Call 585-420-6471 to connect with a bilingual (English/Spanish) operator, who can activate a network of volunteers who have been trained to respond effectively.
